### **OLD BUSINESS**

Zoning and Comprehensive Plan Update – Planning Commission Chairman, Aryn Hedrick, reported the update project with John Riggs is 34.1% complete. John Riggs has held two training sessions with the Planning Commission and Aryn informed the Council that they are encouraged to attend any meeting or trainings if they desire. The meetings are at 7 p.m. on the last Monday of every month here at City Hall. The base mapping, population and land use are the items currently being worked on within the update. Council Member Richard asked if the process including gathering information and suggestions from public. Aryn stated that surveys have been discussed. Council Member Rohling suggested mailing out letters and putting the information on Channel 7 and inviting the public to the planning and zoning meetings.

**Community Center Acoustic Panels -** Clerk Beshears researched and put together three options for sound absorbing acoustic panels for the Community Center. After reviewing the options, Council chose the 24 panel package from Acoustimac for \$1320 plus shipping.

**EBH Contract** – Clerk Schmitt relayed information from Don Heller with EBH that they plan on asking for bids for the lagoon renovation project after the first of the year. Construction is planned to commence by March 2017. GEO Tech has completed the ground testing. A recirculation pump is planned from cell 3 to cell 1 to help with the odor complaints.

The EBH Contract for engineering services to renovate the sewer lagoon was reviewed by the Council.
